### LA County Library Director Skye Patrick

Library Journal's 2019 Librarian of the Year

Skye Patrick, LA County Library Director, is the recipient of the *Library Journal*'s 2019 Librarian of the Year Award. The award recognizes a professional librarian for outstanding achievement and accomplishments reflecting the loftiest service goals of the library profession, including free access to information for all, encouragement of reading, creation of incentives to increase use of materials, enhancement and expansion of library service to all residents, and strengthening of the role of the library within the community.

"It is a great honor to be recognized by Library Journal, one of the industry's most reputable publications," said Patrick. "This is not only a recognition for me but also a recognition for the entire LA County Library team. They work so hard and are committed to providing the best service to our customers; without the support of our staff, I would not be able to achieve what I have set out to do."

Skye Patrick joined LA County Library in February 2016, with ambitions to champion change and position the Library

as a center of learning accessible to all residents of Los Angeles County. Her transformational leadership has created an amazing culture of service and innovation at LA County Library.

In continued efforts to break down barriers and increase access for all customers, Patrick launched the *iCount* equity initiative, which ensures that the Library's services and programs address the needs of the diverse community it serves.

To support the innovative programming at the Library, Patrick expanded service hours by over 15,000 hours across 75 library locations without incurring additional costs. Under her leadership, the Library introduced many award-winning programs such as The Great Read Away fine reduction program for youth, Turns the Tables DJ workshops for young adults, and MâkMô maker mobiles. Patrick also established a Marketing team—which was awarded 2018 Marketer of the Year by *Library Journal*—with the goal of improving the Library's promotional efforts and creating awareness of the myriad of services the Library offers.

Understanding the importance of technology, Patrick continues to work to meet customer needs by improving the Library's information technology infrastructure. A new digital alliance with Microsoft allows the Library to begin updating the operating system of over 2,200 public computers in 2019, and funding from the Federal Communications Commission's Schools and Libraries program will enable the Library to work toward increasing its internet bandwidth for a faster internet connection, also starting this year.

"Libraries are important to the well-being of communities," said Patrick. "I am committed to seeking creative and innovative ways to offer Library services that help improve the quality of our customers' lives."



## The Joshua Goldman Odyssey to Weight Loss

One year ago, I weighed 300 pounds. I was on a cane whenever my left ankle would go on strike, and I had to go to Urgent Care six times in one year with uncontrollable asthma. Medical bills cause more than half of the bankruptcies in our country, and I was quickly becoming a statistic. I decided to try out the Interagency Greatest Loser program, where teams in the County compete to lose the most weight. This attempt involved cutting back my snacking and how much I ate, while walking more whenever I could. When the Greatest Loser finished, I was excited to weigh in, only to find out that I had gained half a pound. Rather than be discouraged, I remembered that my past supervisor, Mary Gilmore, once told me that it's impossible to know how much weight you didn't gain by making changes, so I turned to science to figure out what I was doing wrong.

In April, having never successfully dieted before, I set the goal of losing 100 pounds in one year. My research into the ketogenic diet taught me the basics of how weight gain happens: Insulin tells your body to use sugar and store fat, so by restricting carbohydrate intake to 30 g or less a day, your body will burn fat for energy instead. Having to track my food and look up macronutrients made me more mindful of what I ate, and the decrease in processed food made me feel better. My hunger and cravings throughout the day vanished, as my body remained in ketosis, but I also felt strange the entire time, an effect called "keto flu." While I lost an unprecedented 20 pounds that month, I did not like how keto made me feel, so I sought out a more long-term solution.

As a result of extensive nutritional research, I spent May transitioning from dieting to completely changing my lifestyle, moving from a low carb diet to a plant-based lifestyle. I found a wealth of information online. The diet consists of foods with lower calories, such as beans, potatoes, and rice with plenty of fruits and vegetables. Starches and legumes are highly satisfying, so the hunger that had doomed me was no longer a problem. Since my diet had become more restrictive, I needed to learn how to cook. I went from being a criminally terrible cook to batch cooking soups, chili, and dozens of other recipes. Cooking my own food cut my daily food cost from \$20 to \$8, a \$4,000 a year savings! More importantly, I truly felt healthy for the first time in my life.

Seven months have passed now, and I have lost a total of 80 pounds out of my 100-pound goal. The asthma that had nearly led me to an old-timey death is almost non-existent, and I have not needed medical assistance since switching to a plant-based diet. For 2019, I plan to lead a team in the "Interagency Greatest Loser" and inspire others to finally lose the weight. ## Start the Year Out Right and Practice Financial Fitness

How homeowners can save on their property taxes

Setting financial goals is a common New Year's resolution. Los Angeles County Assessor Jeffrey Prang and the Board of Supervisors want to help homeowners reach small attainable goals. One way homeowners can begin the year off right is by applying for the Homeowners' Exemption, which helps homeowners save on their property taxes.

**THIS IS HOW IT WORKS:** This exemption reduces a property's taxable assessed value by \$7,000, provided that the property is the owners' principal place of residence as of January 1<sup>st</sup>. The result is \$70 savings on the annual tax bill. Homeowners need only apply once in order to receive the savings each year or until a change in ownership is recorded.


